## All managers, coaches, players, parents and fans are hereby notified that league rules prohibit anyone from:

- Harassing any umpire, player, opposing player, manager, coach or league official.
- Team managers are responsible for the good conduct of their coaches, players, parents and fans during games.

#### Any manager, coach, or player violating the Code of Conduct is subject to:

• Immediate ejection from the game by the umpire or league official and subsequent suspension as well as disciplinary action from the Board of Directors according to League Rules

#### Any parent or fan violating the Code of Conduct will be :

• Given a warning by the umpire in charge that they are in violation of the leagues rules and its Code of Conduct

## In the event that there is the need to address the violation a second time, during the same game, the umpire in charge will:

- Stop the game and ask Managers to return their teams to their respective dugouts and then inform the stands that the play will be suspended until the offending individual(s) leave the facility.
- In the event that the offending individual(s) refuse to comply, the manager of the
  offending team will be responsible for compliance and both the OFFENDER AND THEIR
  PLAYER face suspension and additional disciplinary action from the Board of Directors.
- It will result in a forfeiture of the game and subject the manager of the team to disciplinary action from the Board of Directors according to league rules as well.
